



Phoenix School of Law 2010 Graduate Employment Statistics

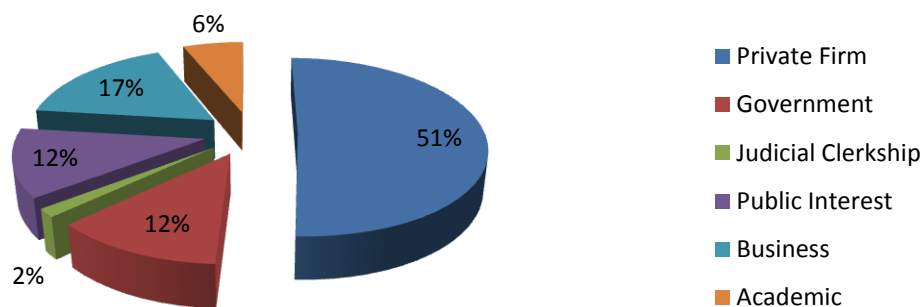
Phoenix School of Law had 70 students in its 2010 graduating class. The data below reflects the employment status of our 2010 graduates as of February 15, 2011.

Employment Data:

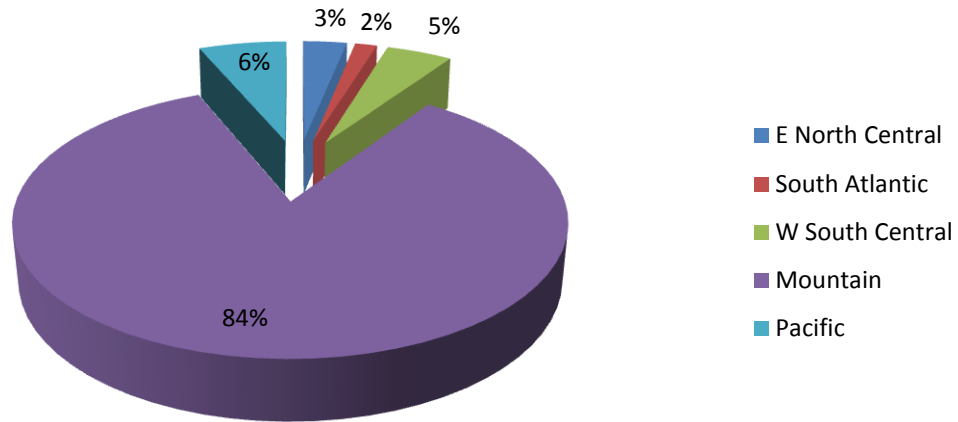
Our office was able to confirm the employment status of 70 of our 70 graduates (100% of the class). The employment status of the 70 graduates is as follows:

- 65 (92.8%) are employed; 100% of these jobs are JD Required, JD Preferred or Professional positions
- 1 (1.4%) is enrolled in a full-time degree program;
- 2 (2.9%) are seeking employment;
- 2 (2.9%) are unemployed and not currently seeking employment; and
- 0 (0%) are unknown

Financial and Placement Statistics At-a-Glance:

As of the 2010-11 academic year, tuition and fees for the 3 year JD program total \$101,310.00. Books and supplies for the program total \$2,184.00.

The median cumulative program debt for PhoenixLaw graduates between July 1, 2009 and June 30, 2010 is \$93,142.51 for federal student loan debt and \$5,000.00 for private student loan debt .

For July 1, 2009 – June 30, 2010, 90% of PhoenixLaw graduates completed the program in 3 years.

From July 1, 2009 – June 30, 2010, the job placement rate for PhoenixLaw program completers was 93%.
